Following are the main features of the Scheme:

- 1. Sons and daughters of parents (Father & Mother both) whose annual income is less than Rs. 8.00 lakhs from all sources shall only be eligible.
- 2. The waiver is limited to the Tuition Fee only. All other fees except Tuition Fee will have to be paid by the beneficiary student.
- 3. The eligible candidates have to apply in the given format. The following documents are to be attached along with the Application:
  - a. Declaration by parents regarding income.
  - b. Copies of ITR for the FY 2025-26 for both the parents duly attested by the respective assesses.
  - c. Salary Certificate/Pay slip self attested (attested by the respective employees) in case of a parent who is employed.
  - d. Original Certificate of Income issued by Tahsildar/Competent Authority (in case (b) above is not applicable).
  - e. Declaration regarding exemption from Income Tax (duly signed by individual parent in whose case (b) above is not applicable.
